Sanction is hereby accorded to the:-

- i. Grant of extension (with and without deficiency/ies) in the period of recognition in favour of 305 Private Academic Institutions of Jammu Division for the period as mentioned against each, forming Annexure "A & B." to this order.
 - ii. Up-gradation (with, without and review cases) in favour of 55 Academic Institutions of Jammu Division upto High/Higher Secondary level for the period as mentioned against each, forming Annexure "C,D,E to this order.
 - iii. Change in nomenclature/Zone/New Establishment in favour of 05 institute of Jammu Division forming Annexure "F,G & H" to this order.

The above sanction is, however, subject to the condition that Director, School Education, Jammu and Secretary, J&K BOSE have strictly followed all the rules and guidelines pertaining to the grant of affiliations with regard to extension in recognition and up-gradation.

The sanction shall be, further subject to the condition that the management of the schools shall fulfill all the deficiencies as indicated by Affiliation Committee, mentioned against each in the annexures to the order, within a period of three months from the date of issuance

of this order, failing which extension in recognition/up-gradation granted shall be treated as withdrawn without giving any further notice.

The above sanction shall be further subject to the fulfillment of the following conditions:

- i. The recognition is co-terminus with the period of affiliation granted by J&K BOSE/Affiliation Committee.
- ii. Compliance to the condition prescribed in the NOCs issued by the competent authorities and in particular, the School Education Department pertaining to safe transportation of children, boarding/de-boarding arrangements and deployment of personnel for the purpose & also formulation of proper traffic management plan, etc.
- iii. Strict compliance to the directions/decisions of the Committee for regulation/Fixation of Fee structure constituted by the Government.
- iv. Adherence to terms and conditions of affiliation orders issued by J&K BOSE.
- v. The recognition/up-gradation so accorded is liable to be withdrawn/cancelled in case there is violation or non-adherence to conditions.
